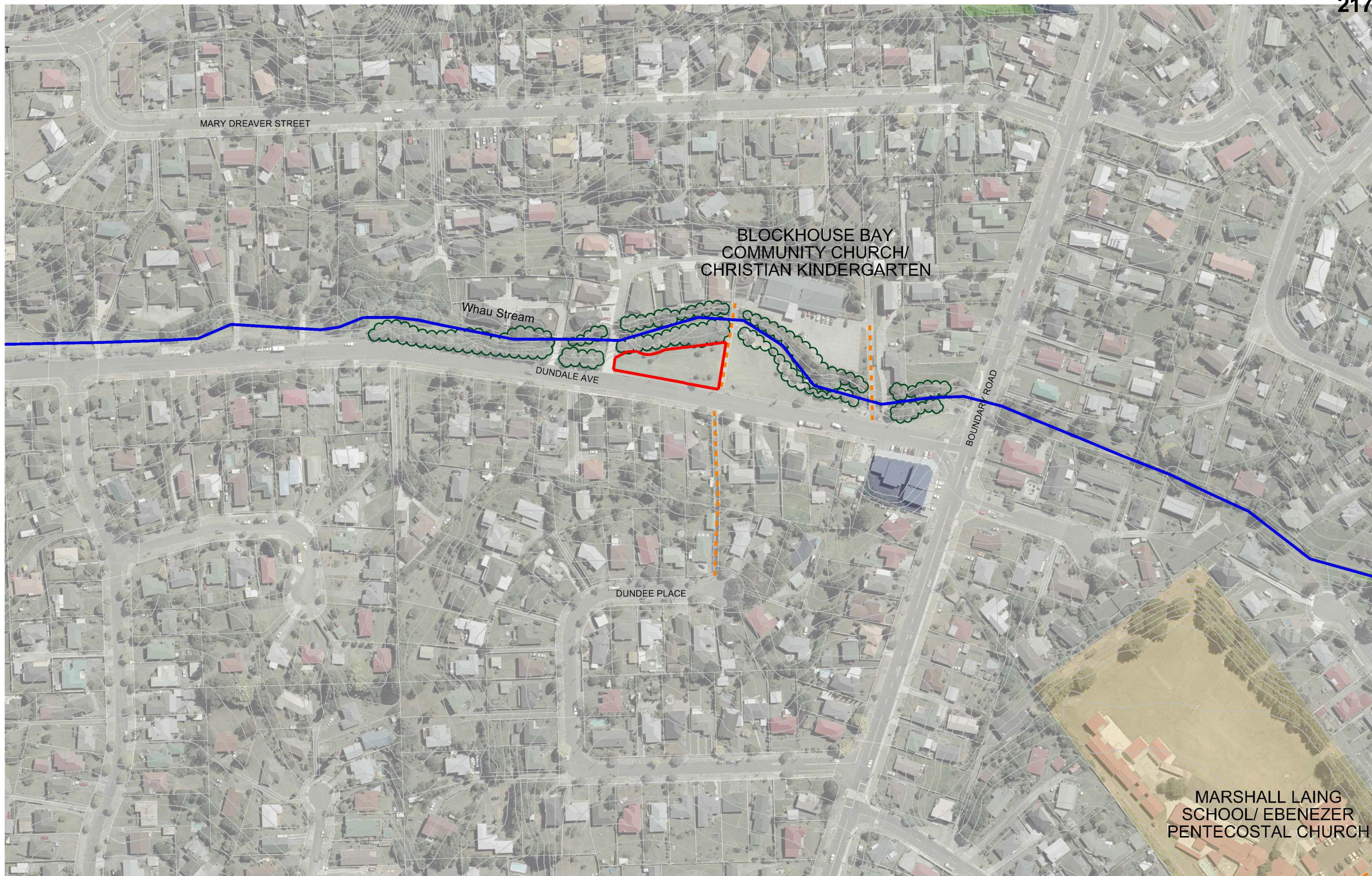

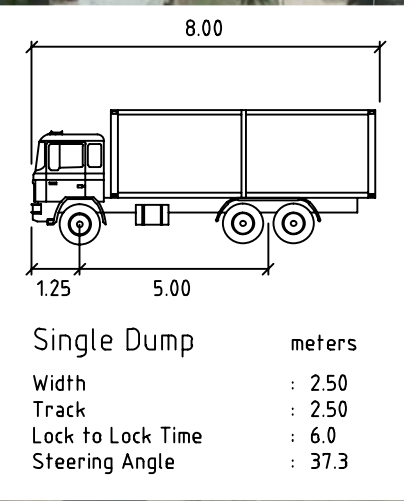
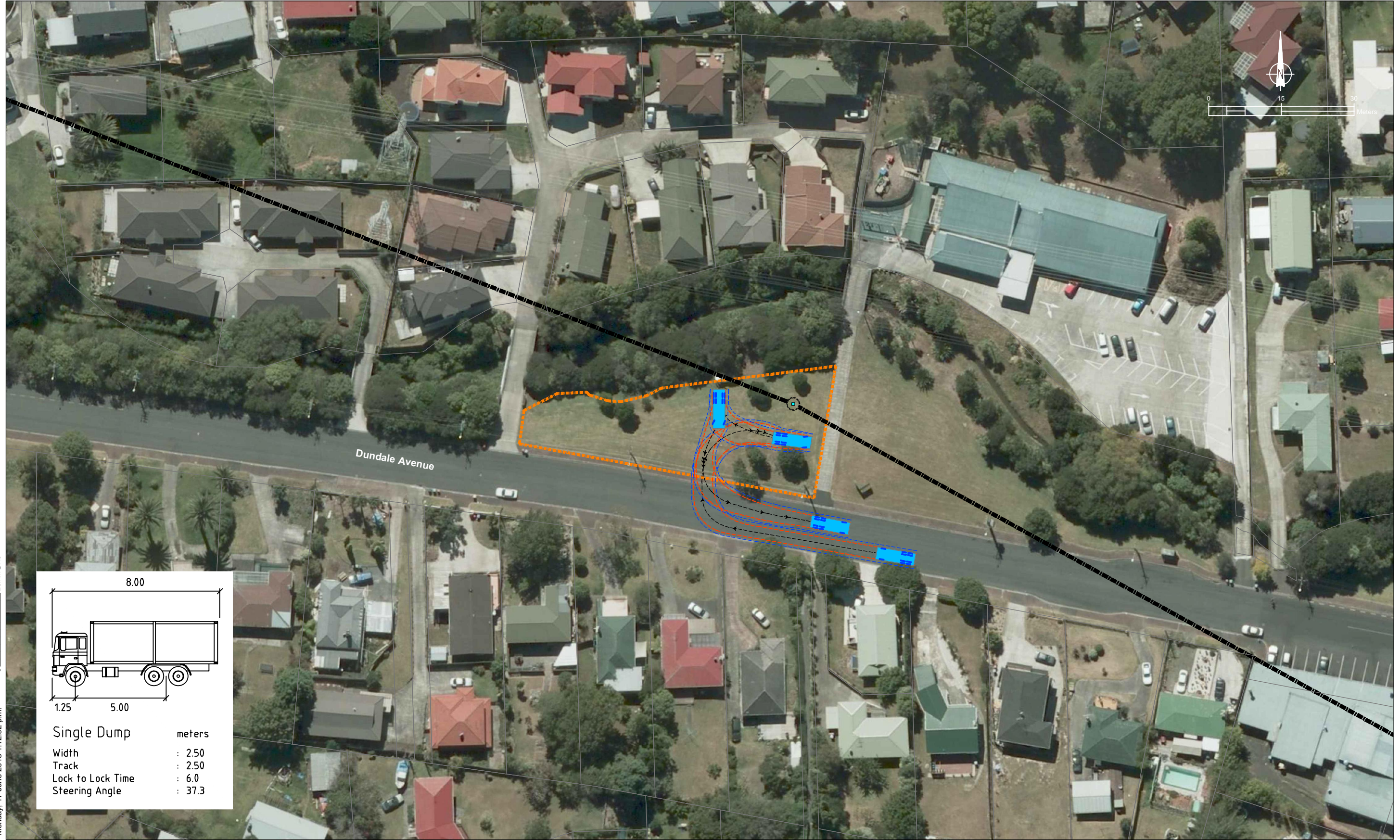
View from footpath looking West

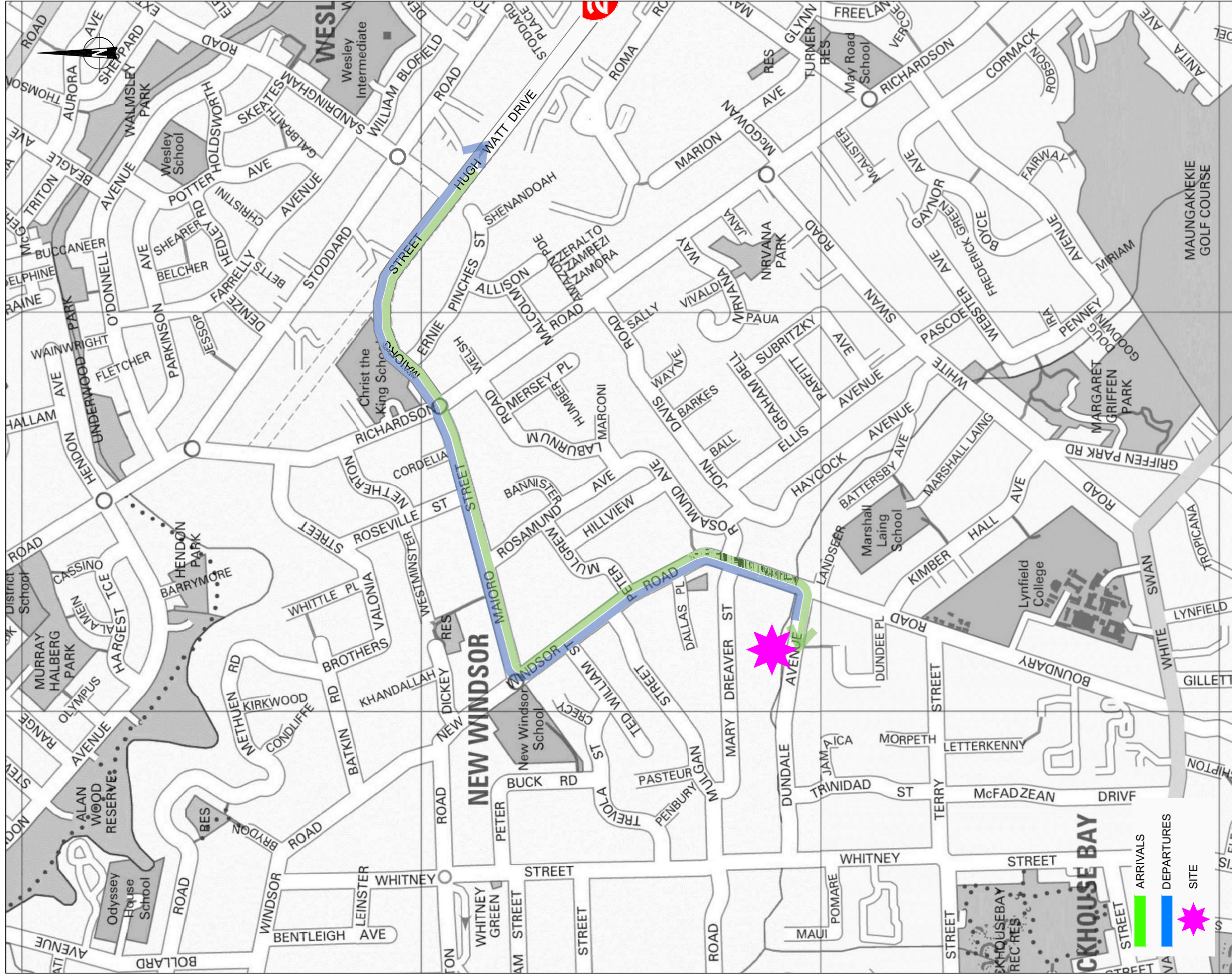
